Black Rivers Bullmastiff Purchase Agreement and Health Guarantee

Health Guarantee: Black River Bullmastiff guarantees the said dog, described above, is in good health at time of change of ownership. The said dog has been inoculated against Distemper, Adenovirus Type 2, Para influenza, and Canine Parvovirus, and is current on the worming process. The parameters of the health guarantee are as stated: You the buyer have up to ten days, beginning from the date of purchaser taking possession of dog, to inspect the puppy's health. Said dog must be examined by a licensed veterinarian in the ten day period, if any serious defect is discovered at this time the owner has one week past the ten day period to provide Black River Bullmastiff with evidence of said serious defect. This defect will not be covered if it is due to neglect or any actions of the buyer. If serious health issue should arise in this guaranteed time, the said dog will be replaced by another dog of equal or greater value when substitute is available. The said dog must be returned with papers and certified statement from veterinarian with in the guaranteed time. It is further agreed and understood that no money will be refunded, including any veterinarian bills incurred by purchaser.

Said dog is further guaranteed up to two years from its whelping date, against any crippling Hip dysphasia or genetic disability. The claim must be made with in the two year guarantee. A licensed veterinarian must give a written and certified assessment of the disability; and it must be stated that said defect is not due to neglect of the buyer; all proof of said disability is also to accompany certified statement. The dog must be returned to Black River Bullmastiff at expense of buyer, with all papers with in the two year guarantee. The dog will be replaced with another dog of equal or greater value as soon as one is available.

Liability: Black River Bullmastiffs and owners' of Black River Bullmastiff assume no responsibility for the said dog after dog leaves sellers premises; this includes but is not limited to medical bills, bill incurred from family members, or bills incurred from loss or damage to property, or any other loss not listed. Once the dog leaves the care of Black

River Bullmastiffs, all liability after date of possession is the sole the responsibility of the purchaser; Black River Bullmastiff cannot be held responsible for anything that is not covered under the health guarantee. Under no circumstances will Black River Bullmastiff be obligated to refund or pay any bills acquired on said dog after purchaser takes possession of the dog; liability is now transferred to purchaser. We as breeders strive to produce quality dogs, in good health with predictable and stable temperament; it is the buyer's responsibility to assure that these standards are maintained after possession of dog takes place.
